Executive Summary

The Index of Multiple Deprivation 2007 (IMD 2007) is a nationally recognised measure of deprivation at the small area (Super Output Area – SOA) level. It measures deprivation in its broadest sense by assessing indicators relating to income, employment, health and disability, education, skills and training, barriers to housing and services, crime and the living environment.

It is an important tool for identifying the most disadvantaged areas in England and can be used locally to help prioritise services and resources to help tackle health inequalities and social exclusion.

Shropshire Results

- In terms of deprivation overall, 2% of Shropshire County's population live within the most deprived fifth of areas in England. This has remained unchanged since 2004.
 Only 4 Shropshire SOAs fall within the most deprived fifth nationally. These are located in Harlescott, Meole Brace, Monkmoor and Castle. 13% live within the least deprived fifth – this represents a 3% decrease from 2004.
- 11.0% of Shropshire's population, 13.2% of children and 15.4% of older people live in income deprivation. These percentages are higher than in 2004 but are still lower than the England average.
- 7.9% of Shropshire's working age population is employment deprived.
 This rate has improved since 2004 and is lower than the average for England.
- 2% of Shropshire's population live within the most deprived fifth of areas in England when it comes to health deprivation and disability.
- In terms of education, skills and training deprivation, 6% of Shropshire's population live within the most deprived quintile. Levels are highest when looking specifically at adults.
- The barriers to housing and services domain overall, and particularly the wider barriers sub-domain experienced profound change since 2004 with Shropshire County becoming more deprived. Overall, 40% of Shropshire's population live within the fifth most deprived areas in England.
 - In terms of wider barriers, 2% of Shropshire's population live within the most deprived fifth of areas in England. Whereas in 2004, the majority of Shropshire's population lived within the least deprived fifth of areas nationally, only 4% do so in 2007.

Shropshire being a rural County experiences high levels of geographical barriers deprivation, with 47% of its population living within the most deprived quintile.

- 3% of Shropshire's population live within the most deprived fifth of areas in England for crime.
- 8% of Shropshire's population live within the most deprived quintile for the living environment. 22% fall within this quintile for the 'indoors' subdomain whereas only 1% do so for the 'outdoors' sub-domain.

County and District Summary

- Overall, Shropshire is a relatively affluent area. Using the average population-weighted scores, Shropshire is ranked as being the 106th most deprived County out of 149 Counties in England (111th in 2004).
- There are six summary measures that can be used at District level, these are: Average Score, Average Rank, Extent, Local Concentration, Income Scale, and Employment Scale. Out of all Shropshire Districts, Shrewsbury and Atcham appeared the most deprived in terms of all of these except average score (Oswestry) and average rank (North Shropshire). Bridgnorth appeared least deprived in terms of all measures except income scale and employment scale (both South Shropshire).

Introduction to the Indices of Deprivation 2007

The Index of Multiple Deprivation 2007 (IMD 2007) is a nationally recognised measure of deprivation at the small area level. It is an important tool for identifying the most disadvantaged areas in England and can be used locally to help prioritise services and resources to help tackle health inequalities and social exclusion.

The Department for Communities and Local Government commissioned the Social Disadvantage Research Centre (SDRC) at the Department of Social Policy and Social Work at the University of Oxford to update the IMD 2004 for England.

The new Indices of Deprivation 2007 were produced in December 2007. Although the update is branded as the 2007 version, the majority of data used to construct it was actually taken in 2005 and thus reflects deprivation at that time.

HOW THE INDEX IS CALCULATED

The model of multiple deprivation which underpins the IMD 2007 is based on the idea of distinct dimensions of deprivation (domains), each with their own additive impact on multiple deprivation, which can be recognised and measured separately.

The IMD 2007 brings together a total of 38 different indicators across 7 domains. The scores for each domain are weighted as follows and combined to create the overall IMD 2007 score:

Domains of deprivation	Examples of measures	Weighting
Income	Households on range of benefits	22.5%
Employment	Recipients of Jobseekers Allowance or Incapacity Benefit	22.5%
Health, Deprivation and Disability	Mortality rates, hospital admissions	13.5%
Education, Skills and Training	Educational attainment, truancy	13.5%
Barriers to Housing and Services	Housing overcrowding, access to owner-occupation and services (e.g. GP surgery)	9.3%
Crime	Burglary, theft, criminal damage, violence	9.3%
Living Environment	Housing condition, air quality	9.3%

The IMD 2007 is based on the small area geography known as Super Output Areas (SOAs). There are 32,482 SOAs in England, each with an average population of 1,500 people. There are several types of SOAs – lower layer SOAs are the kind used for the IMD.

Each SOA in England is scored for each domain of deprivation and receives an overall IMD 2007 score.

DOMAINS

The Income Deprivation Domain measures the percentage of people living in low-income families and also includes two sub-domains:

- The IDACI score (Income Deprivation Affecting Children) is the proportion of children 0-15 living in income-deprived households as a proportion of all children 0-15.
- The IDAOPI score (Income Deprivation Affecting Older People) refers to adults 60 or over living in pension credit (guarantee) households as a proportion of all those 60 or over.

The Employment Domain measures the percentage of people who want to work but are unable to do so due to unemployment, sickness or disability.

The Health and Disability Domain identifies areas with relatively high rates of people who die prematurely or whose quality of life is impaired by poor health or who are disabled.

The Education, Skills and Training Domain measures the lack of qualifications amongst children and adults. It is made up of two sub-domains:

- Children and young people.
- Skills (working age adults).

The Barriers to Housing and Services Domain is made up of two sub domains:

- Wider barriers: refers to issues relating to access to housing (overcrowding and affordability) and homelessness.
- Geographical barriers: measures poor geographical access to key services such as supermarkets and primary schools.

The Crime and Disorder Domain measures the rate of recorded crime across four major crime themes (burglary, theft, criminal damage and violence).

The Living Environment Domain is divided into two sub-domains:

- The indoors living environment measures the quality of housing.
- The outdoors living environment contains measures about air quality and road traffic accidents.

HOW THE SCORES ARE ANALYSED

Each SOA is ranked according to its score, from 1 (most deprived in England) to 32,482 (least deprived in England). These SOAs are then split into **national deprivation quintiles** (comparing scores across England). Unless specifically mentioned, these were used in this report.

To get a more meaningful local picture, each SOA in Shropshire County is ranked from 1 (most deprived in Shropshire) to 192 (least deprived in Shropshire). Shropshire SOAs are then divided into **local deprivation quintiles** (comparing SOAs within Shropshire County itself) which will be used for the future profiling and monitoring of health and social inequalities in Shropshire County.

Maps representing local as well as national quintiles have been used in this report.

The results are then summarised at County Council and District level. The IMD 2007 scores together with these summaries are sometimes referred to as the ID 2007 (Indices of Deprivation).

Six summary measures of the overall IMD 2007 have been produced at County and District level to allow comparisons to be made between Counties and Districts in England. These are presented in the 'County and District Summary' chapter.

COMPARABILITY WITH IMD 2004

The IMD 2007 updates the IMD 2004, for the most part retaining the same methodology, domains and indicators.

This has, however, not been possible for the income domain where as a result of major changes to the social security system, particularly in the area of tax credits, indicators have ceased to exist. Where possible, indicators were selected in that domain which map as closely as possible to their predecessors.

The IMD 2007 is therefore comparable to the IMD 2004 - most change is likely to reflect real relative change in deprivation between 2004 and 2007. However, caution should be exercised around income domain score comparisons.

In contrast, comparability of the IMD 2004 to its predecessor, the IMD 2000, is not possible since significant changes were made to its domains.

IMPORTANT POINTS

The ID 2007 identifies concentrations of deprivation. Population numbers quoted in our results refer to those living in areas of particular deprivation concentrations — not all deprived people live in deprived areas and conversely, not everyone living in a deprived area is deprived.

It is also important to note that an area's index score rank is affected by the scores of every other area. So it is impossible to tell whether a change in score with time is a real change in the level of deprivation in the area or whether it is due to the scores of the areas going up or down.

Shropshire County profile

Shropshire is a diverse, large, predominantly rural inland county, situated in the West Midlands. With a population of just 289,300 and at only 0.9 persons per hectare, the County is one of the most sparsely populated in England.

The County contains several small market towns; only four of these have a population of over 10,000 according to the 2001 Census. Shrewsbury is the County town, has the status of sub-regional foci in the adopted Regional Spatial Strategy (RSS) (a spatial strategy which sets out the region's policies in relation to the development and use of land and forms part of the County's development plan). In the emerging RSS, Shrewsbury is defined as a 'settlement of significant development'. The town is home to around a quarter of the County's population and is a key employment, shopping and cultural centre for Shropshire and mid-Wales, and a popular destination for tourists and visitors.

Shropshire's historic market towns provide jobs and a range of local shops and services for their resident communities and large rural hinterlands. The County's economy is based mainly on agriculture, tourism, food industries, healthcare and other public services.

Shropshire has strong links with the neighbouring unitary council, Telford & Wrekin. The eastern part of Shropshire also has strong connections with the West Midlands conurbation. Parts of North Shropshire have strong links with the Potteries and with towns in south Cheshire, and are also influenced by Merseyside and Manchester. Oswestry, the second largest town in Shropshire, has strong links with adjacent areas within Wales. The southern and western parts of the County are generally more remote and self contained and have been identified as a Rural Regeneration Zone.

Shropshire has a rich and varied natural and historic environment. About one third of the County is upland, mostly to the south and west, the highest point being Brown Clee at 540 metres. Almost 81,000 hectares of the South Shropshire hills are designated as an Area of Outstanding Natural Beauty and contain a variety of landscapes varying from arable farming to remote moorland and extensive woodlands (this includes 491 hectares in Telford and Wrekin). Approximately 2% of Shropshire is covered by Sites of Special Scientific Interest and woodland covers 7.7% of the land area.

Key Facts

- In 2006 there were 289,300 people living in Shropshire, of which 142,800 were men and 146,200 women. (2006 Population Estimates Mid-2006 National Statistics)
- In 2001, 1.2% of the population have identified themselves as being black, mixed or from other minority ethnic groups – this rate is lower

- than the West Midlands and England average. (2001 Census, National Statistics)
- Shropshire has 26% of its population aged over 60, and less than 25% are under 20. (2006 Population Estimates Mid-2006 National Statistics)
- Shropshire has a working age population of 170,500 people (59%).
 (2006 Population Estimates Mid-2006 National Statistics)
- There are 52,700 children (under 16) in the County, making up 18% of the total population. (2006 Population Estimates Mid-2006 National Statistics)
- Between October 2006 and September 2007, there were 148,800 economically active residents in Shropshire, and 32,200 economically inactive residents. (Annual Population Survey 2007, National Statistics)
- 19.9% of those employed work from home this is higher than the national and regional figures. (2001 Census, National Statistics)
- 53.6% of the households in Shropshire have 2 or more cars or vans, compared to 54.9% in England (*Census 2001, Office of National Statistics*).
- In 2001 there were 123,240 jobs in Shropshire and 135,465 resident workers. 76% of resident workers lived and worked in Shropshire. 83% of the jobs in Shropshire are filled by Shropshire residents. (2001 Census, National Statistics)
- The service sector is the largest employer in Shropshire, accounting for 78.5% of all jobs. Manufacturing accounts for 12.5% and agriculture accounts for 3.1%. (Annual Business Inquiry 2006. National Statistics (NOMIS))
- The majority of companies in Shropshire are classified as being small (less than 25 employees). However there are a number of major employers (greater than 400 employees) across the county. (Shropshire Business and Information System (SBIS) 2007)




Figure 1 Shropshire County Overview

- Area of Outstanding Natural Beauty (AONB) areas of national importance for their landscape character and appearance, within which conservation and enhancement of their natural beauty is a priority. These are designated under the Natural Parks and Access to the Countryside Act 1949 by the Secretary of State for the Environment.
- **Greenbelt** an area of land, usually around a city or conurbation within which there is a presumption against urban development.

 These are Harlescott, Meole Brace, Monkmoor and Castle.

This section refers to the overall IMD score, as outlined in the introduction.

SHROPSHIRE COUNTY

In 2007, 2% of Shropshire County's population lived within the most deprived fifth of areas in England. This has remained unchanged since 2004.


In contrast, 13% of the population lives within the least deprived fifth. This represents a 3% decrease from 2004 (Graph 1).

There is a higher proportion of Shropshire's population living within areas falling in the 3rd most deprived quintile (38%) than in any other single quintile (Table 1).




SHROPSHIRE DISTRICTS

In Shropshire, the District with the highest proportion of its population living within the most deprived fifth of areas in England is Shrewsbury and Atcham (5%). North Shropshire, South Shropshire and Bridgnorth on the other hand, do not have any inhabitants within these areas.

23% of Bridgnorth residents live within the least deprived fifth of areas in England – this is the highest percentage out of all Shropshire Districts (Table 2).

North Shropshire became comparatively more deprived than other Districts in England since 2004, with a 6% decrease in quintile 3 and a corresponding increase in quintile 2 (Graph 2).


Graph 2 IMD 2004 and 2007 by national quintile for North Shropshire


The change for **Oswestry** since 2004 has been less clear. The most notable changes have been a 13% decrease in quintile 3, a 6% increase in quintile 2 and a 7% increase in quintile 4 (Graph 3).

Shrewsbury and Atcham became comparatively more deprived when compared to other Districts in England since 2004. It experienced a 5% decrease in the least deprived quintile, and 3% increases in quintiles 3 and 4. There was also a small drop in quintile 2 with a corresponding increase in the most deprived quintile (Graph 4).


Graph 4 IMD 2004 and 2007 by national quintile for Shrewsbury and Atcham


The most notable change for **South Shropshire** since 2004 was a 12% increase in quintile 2, a decrease of 9% in quintile 3 and of 3% in the most deprived quintile (Graph 5).

Bridgnorth experienced a 6% drop in the least deprived quintile. Quintiles 2, 3 and 4 experienced a small increase (Graph 6).

SHROPSHIRE SOAs

Of the 192 SOAs in Shropshire, only 4 fall within the most deprived quintile nationally (Table 3). These are located within the electoral wards of **Harlescott, Meole Brace** and **Monkmoor** in Shrewsbury and Atcham District and **Castle** in Oswestry District. The number of SOAs which fall into the most deprived quintile nationally has increased from 3 to 4 since 2004.

The number of SOAs which fall into the least deprived quintile has also fallen from 28 to 23 since 2004. The least deprived SOA in 2007 fell in the ward of **Bridgnorth Castle** in Bridgnorth.

SOAs in the wards of **Monkmoor** in Shrewsbury and Atcham District and **Castle** in Oswestry District are now in the most deprived quintile nationally whereas in 2004 they were not.

An SOA in the ward of **Ludlow Henley** is no longer in the most deprived quintile, however it still remains the most deprived SOA in South Shropshire.

An SOA in the ward of **Ludlow Sheet with Ludford** in South Shropshire has experienced the greatest improvement in terms of deprivation levels. Its national percentile ranking went from 73% in 2004 to 85% in 2007 (quintile 4 to 5).

An SOA in the ward of **Sutton and Reabrook** in Shrewsbury and Atcham District has experienced the greatest decline – its national percentile ranking decreased from 88% in 2004 to 74% in 2007 (quintile 5 to 4).



Income deprivation

SUMMARY

- 11.0% of Shropshire's population, 13.2% of children and 15.4% of older people live in income deprivation.
- These percentages are higher than in 2004 but are still lower than the England average.
- Overall, Oswestry has the highest rates of income deprivation in Shropshire (12.3%) and Bridgnorth the lowest (9.5%).
- At an SOA level, the percentage of people who live in income deprivation overall ranges from 2% to 37%.
- The most deprived SOA overall fell in the electoral ward of Harlescott.
- The most deprived SOA for children and older people fell in the electoral ward of Monkmoor.

Income deprivation is considered to be one of the most important aspects of deprivation and subsequently is given a weighting of 22.5%. This domain measures the percentage of people living in low-income households.

The income deprivation domain includes two sub-domains:

- Income Deprivation Affecting Children Index (IDACI) this
 measures the proportion of children under 16 who are living in families
 in receipt of means-tested benefits or in families in receipt of working
 families or disabled person's tax credits but whose income (before
 housing costs) is below 60% of the median income
- Income Deprivation Affecting Older People Index (IDAOPI) this measures the percentage of the population over 60 who are living on means tested benefits

The following indicators have been used to calculate the income deprivation scores:

- Adults and children in Income Support Households (2005)
- Adults and children in Income-Based Job Seekers Allowance Households (2005)
- Adults and children in Pension Credit (Guarantee) Households (2005)
- Adults and children in those Working Tax Credit households where there are children in receipt of Child Tax Credit whose equivalised income (excluding housing benefits) is below 60% of the median before housing costs (2005)
- Adults and children in Child Tax Credit Households (who are not eligible for Income Support, Income-Based Job Seekers Allowance, Pension Credit or Working Tax Credit) whose equivalised income

- (excluding housing benefits) is below 60% of the median before housing costs (2005)
- National Asylum Support Service (NASS) supported asylum seekers in England in receipt of subsistence support, accommodation support, or both (2005)

Caution should be exercised around making comparisons with the IMD 2004 for the income domain, since some indicators used in the IMD 2007 have been altered following major changes to the social security system.

Scores for this domain are calculated in a different way to most of the others – the scores represent actual rates of deprivation on an individual basis rather than allocating an overall score to whole SOAs.

SHROPSHIRE COUNTY

Income deprivation overall

The proportion of people living in income deprivation has increased in Shropshire from 9.4% in 2004 to 11.0% in 2007. This is lower than the England average of 15.6%.

Income deprivation affecting children

The proportion of children under 16's living in income deprivation increased slightly – from 12.9% to 13.2%. This is significantly lower than the England average of 21.0%.

Income deprivation affecting older people

People over 60 experienced a large increase – from 12.9% to 15.4% (Table 4). This is however still significantly lower than the average for England of 20.0%.

Figure 4 Income Deprivation in Shropshire County




Figure 5 Income Deprivation affecting Children in Shropshire County





Figure 6 Income Deprivation affecting Older People in Shropshire County



SHROPSHIRE DISTRICTS

Income deprivation overall

Oswestry is the most deprived District in Shropshire (12.3% of its population) and Bridgnorth the least (9.5%).

All five Districts retained the same relative rank when compared to each other as in 2004.

Since 2004, all five Districts became more deprived. The proportion of people living in income deprivation increased the most in South Shropshire (by 2.2%).

Income deprivation affecting children

Oswestry and Shrewsbury and Atcham are the most deprived Districts (14.0% of their population is income-deprived) and Bridgnorth the least (10.2%).

There was not much change in relative ranking of the five Shropshire Districts since 2004 except for Shrewsbury and Atcham that increased its proportion of children living in income deprivation to match Oswestry's score, thus becoming the two most deprived Districts.

Since 2004, only Oswestry improved. The percentage of its children living in income deprivation has decreased by 0.8%. South Shropshire's percentage, on the other hand, increased the most (by 0.8%).

Income deprivation affecting older people

Oswestry is the most deprived District in Shropshire (17.1% of its population) and South Shropshire the least (12.4%) (Table 5).

Since 2004, Bridgnorth overtook Shrewsbury and Atcham in terms of being more deprived. The relative ranking of Shropshire's five Districts was otherwise unchanged.

Since 2004, every District in Shropshire became more deprived. The percentage of older people living in income deprivation increased the most in Bridgnorth (by 3.0%).

SHROPSHIRE SOAs

Income deprivation overall

At an SOA level, the percentage of people who live in income deprivation ranges from 2% to 37%.

There are seven SOAs within the most deprived quintile nationally (6 in 2004), including five within the 15% most deprived. These areas are located within **Harlescott, Monkmoor, Meole Brace and Battlefield and Heathgate** wards in Shrewsbury and Atcham District and **Ludlow Henley** Ward in South Shropshire District.

The number of SOAs in the least deprived fifth has fallen from 25 in 2004 to 22 in 2007 (Table 6). The least deprived SOA fell in the electoral ward of **Donington and Albrighton** in Bridgnorth and had a national percentile ranking of 99%. This has remained unchanged since 2004.

An SOA in the ward of **Monkmoor** in Shrewsbury has increased its deprivation levels the most since 2004 with its national percentile ranking decreasing from 94% in 2004 to 75% in 2007 (quintile 5 to 4).

An SOA in the ward of **Gobowen** in Oswestry has decreased in its deprivation levels the most since 2004 with its national percentile ranking increasing from 47% in 2004 to 73% in 2007 (quintile 3 to 4).



Income deprivation affecting children

Levels of child poverty within the County's SOAs range from 2% to 46%.

4 SOAs fall with the most deprived quintile nationally (7 in 2004). SOAs with the highest number of children classed as income deprived are located within the electoral wards of **Monkmoor**, **Harelescott**, **and Battlefields and Heathgates** in Shrewsbury, and **Ludlow Henley** in South Shropshire.

The number of SOAs in the least deprived quintile has fallen from 38 in 2004 to 32 in 2007 (Table 7). The least deprived SOA falls within the electoral ward of **Porthill**.


An SOA in the ward of **Hanwood and Longden** in Shrewsbury and Atcham District has experienced the greatest increase in the proportion of its population living in income deprivation since 2004. Its national percentile ranking went from 57% in 2004 to 36% in 2007 (quintile 3 to 2).

In contrast, an SOA in the ward of **Wistanstow and Hopesay** in South Shropshire has experienced the greatest improvement in terms of deprivation levels. Its national percentile ranking went from 43% in 2004 to 74% in 2007 (quintile 3 to 4).

Income deprivation affecting older people

Levels of deprivation within the County's SOAs range from 3% to 43%.

13 SOAs fall within the most deprived quintile nationally (9 in 2004). SOAs with the highest proportion of older people classed as income deprived are located within the electoral wards of **Monkmoor** in Shrewsbury and Atcham District, **Shifnal Idsall** in South Shropshire and **Gobowen** in North Shropshire.

The number of SOAs falling within the least deprived quintile has risen from 22 in 2004 to 31 in 2007 (Table 8). An SOA in the electoral ward of **Bowbrook** is the least deprived in Shropshire with a national percentile ranking of 99%.


An SOA in the ward of **Whittington** in Oswestry District has experienced the greatest improvement between 2004 and 2007. It saw its national percentile ranking increase from 35% in 2004 to 74% in 2007 (quintile 2 to 4).

An SOA in the ward of **Bucknell** in South Shropshire has experienced the greatest decline between 2004 and 2007. It saw its national percentile ranking decrease from 84% in 2004 to 61% in 2007 (quintile 5 to 4).

Employment deprivation

SUMMARY

- 7.9% of Shropshire's working age population is employment deprived.
- This rate has improved since 2004 and is lower than the average for England.
- In Shropshire, Oswestry has the highest levels of employment deprivation (9.5%) and Bridgnorth the lowest (6.5%).
- The levels of people who are involuntarily out of work ranges from 2% to 20% within Shropshire SOAs.
- An SOA within the ward of Harlescott has the highest deprivation levels in Shropshire.

The employment domain is also considered to be one of the most important facets of deprivation and is weighted at 22.5%. This domain measures the percentage of the working age population who want to work but are unable to do so due to unemployment, sickness or disability. Six indicators were used to calculate the employment deprivations scores:

- Recipients of Jobseekers Allowance for men aged 18-64 and women aged 18-59 (2005)
- Participants in the New Deal for the 18-24s who are not in receipt of Jobseekers Allowance (2005)
- Participants in the New Deal for 25+ who are not in receipt of Jobseekers Allowance (2005)
- Participants in the New Deal for lone parents (2005)
- Incapacity Benefit recipients aged 18-59 (women) and 18-64 (men) (2005)
- Severe Disablement Allowance recipients aged 18-59 (women) and 18-64 (men)


SHROPSHIRE COUNTY

The proportion of the working age population living in employment deprivation in Shropshire has improved from 8.1% in 2004 to 7.9% in 2007 (Table 9). This is lower than the England average of 10.2%.

SHROPSHIRE DISTRICTS

Out of the five Shropshire Districts, Oswestry has the highest levels of employment deprivation (9.5%) whereas Bridgnorth has the lowest (6.5%) (Table 10).

All five Districts retained the same rank relative to each other since 2004.

Three Districts improved their scores from 2004: Oswestry and North Shropshire by 0.5% and South Shropshire by 0.3%. Shrewsbury and Atcham and Bridgnorth however, increased their rates by 0.1% each.

SHROPSHIRE SOAs

The levels of people who are involuntarily out of work ranges from 2% to 20% within Shropshire SOAs.

In total, 9 Shropshire SOAs fall within the most deprived quintile nationally (5 in 2004). Areas in the electoral wards of **Harlescott** and **Meole Brace** in Shrewsbury and **Gobowen and Castle** in Oswestry fall into the top 15% most deprived nationally. These were also the most deprived 4 SOAs in Shropshire in 2004.

The number of SOAs which fall into the least deprived quintile has risen from 10 in 2004 to 15 in 2007 (Table 11). The least deprived SOA in Shropshire falls within the electoral ward of **Donington and Albrighton North**.

The SOA which has experienced the greatest decline since 2004 is located within the ward of **Stokesay** in South Shropshire. Its national percentile ranking went from 49% in 2004 to 33% in 2007 (quintile 3 to 2).

The SOA which has experienced the greatest improvement is located within the ward of **Broseley West** in Bridgnorth District. Its national percentile ranking increased from 39% in 2004 to 59% in 2007 (quintile 2 to 3).



Health deprivation and disability

SUMMARY

- 2% of Shropshire's population live within the most deprived fifth of areas in England and 5% within the least deprived fifth. These rates are similar to those in 2004.
- An SOA in Harlescott is the most deprived in Shropshire.

This domain identifies areas with relatively high rates of people who die prematurely, whose quality of life is impaired by poor health or who are disabled. The scores are derived from four measures:

- Years of potential life lost (2001-2005)
- Comparative Illness and Disability Ratio (2005)
- Measures of hospital admissions (2003-2005)
- The proportion of adults under 60 suffering from mood or anxiety disorders based on prescribing, suicide mortality rate, hospital admissions and health benefits data (2001-2005)

2% of the County's population live within the most deprived fifth of areas in England, 5% live within the least deprived.


The most populated quintile is quintile 4 (with 44% of Shropshire County's population) (Table 12).

Apart from a 1% fall within the least deprived quintile, there has not been much change since 2004 in terms of the proportion of Shropshire's population living within each quintile.

Shrewsbury and Atcham is the only District with a proportion of its population living in the most deprived fifth of areas in England (6% - this represents a 3% increase from 2004).

On the other hand, only 2 Districts have inhabitants within the least deprived quintile: Bridgnorth with 23% (27% in 2004) and Oswestry with 4% (0% in 2004). 6% of South Shropshire's population fell within the least deprived quintile in 2004 whereas none did so in 2007 (Table 13).

Since 2004, **North Shropshire** experienced a 12% drop in its population living in quintile 3 – this was distributed into quintiles 2 and 4.

Oswestry became less deprived, with a shift away from quintile 2 into the less deprived quintiles.

Shrewsbury and Atcham became slightly more deprived with a move away from quintile 4 into the more deprived quintiles.

South Shropshire experienced a move away from quintiles 3 and 5 and a large increase in quintile 2 (by 18%).

Bridgnorth experienced a small drop in the least deprived quintile and a small increase in quintiles 2, 3 and 4.

SHROPSHIRE SOAs

In Shropshire, 4 SOAs fall within the most deprived quintile nationally (3 in 2004). These are located within the wards of **Harlescott**, **Meole Brace**, **Monkmoor** and **Sutton and Reabrook**. The same SOA in **Harlescott** was also the most deprived in Shropshire in 2004.

The number of SOAs which fall into the least deprived quintile has fallen from 9 to 8 since 2004 (Table 14). The least deprived SOA in Shropshire falls within the electoral ward of **Morville**.

An SOA located in **Cleobury Mortimer** saw the greatest decline since 2004. Its national percentile ranking decreased from 71% in 2004 to 46% in 2007 (quintile 4 to 3).

An SOA located in the electoral ward of **Kinnerley** in Oswestry District saw the greatest improvement. Its percentile increased from 43% in 2004 to 63% in 2007 (quintile 3 to 4).



Education, skills and training deprivation

SUMMARY

- 6% of Shropshire's population live within the most deprived fifth of areas in England and 22% within the least deprived fifth.
 An SOA in Harlescott is the most deprived overall.
- In terms of the children and young people's sub-domain, 4% of the County's population live within the most deprived fifth of areas in England and 30% within the least.
- The County is more deprived when looking at working age adults with no or low qualifications, with 13% of Shropshire's population falling within the most deprived fifth of areas in England and only 9% within the least.

This domain measures deprivation in terms of lack of educational attainment, skills and training for children and adults.

The education, skills and training deprivation domain includes two sub-domains:

- Children and young people scores are derived from the following indicators:
 - ➤ Average test score of pupils at key stage 2 (2004-2005)
 - Average test score of pupils at key stage 3 (2004-2005)
 - ➤ Best of 8 average capped points score at key stage 4 (includes results of GCSEs, GNVQs and other vocational equivalents) (2004-2005)
 - ➤ Proportion of young people not staying in school or non-advanced education above 16 (2005)
 - > Secondary school absence rate (2004-2005)
 - Proportion of those aged under 21 not entering higher education (2002-2005)
- **Skills** this relates to the working age adult population. Only one indicator is used to measure this:
 - > Proportion of working age adults with no or low qualifications (2001)


6% of Shropshire's population live within the most deprived fifth of areas in England – this is the least populated quintile. In contrast, 22% live within the least deprived quintile. The most populated quintile is quintile 4 (with 34% of Shropshire County's population) (Table 15).

Since 2004, there has been a slight improvement in education, skills and training deprivation with a small shift away from quintiles 1 (by 2%) and 3 (by 3%) into quintiles 5 (by 1%), 2 and 4 (by 2% each).





The District with the highest proportion of its population living within the most deprived quintile is Shrewsbury and Atcham (10%), whilst the Districts with the smallest proportions were Oswestry and Bridgnorth (each 3%).

Interestingly, Shrewsbury and Atcham is also the District with the highest proportion of its total population living within the least deprived quintile (37%) (Table 18).

Since 2004, **North Shropshire** became less deprived since 2004 with a shift away from quintiles 2 and 3, into quintiles 4 and 5.

Oswestry experienced a similar shift into quintile 2 and 4.

The most notable change for **Shrewsbury and Atcham** was a 5% increase within the least deprived quintile.

South Shropshire became slightly more deprived with a shift away from 3 and 5, into quintiles 2 and 4.

Bridgnorth experienced a small shift away from both extremes of the most and least deprived quintiles.

The District with the highest proportion of its population living within the most deprived fifth of areas in England is Shrewsbury and Atcham (7%). Bridgnorth has none of its population living within these areas.

Bridgnorth has the highest proportion of its population living within the least deprived fifth of areas in England (43%) (Table 19).

Since 2004, **North Shropshire** became less deprived, with a move away from quintiles 2 (by 6%) and 3 (by 12%) into quintiles 4 (by 6%) and 5 (by 8%).

Oswestry experienced a 5% drop within quintile 4 and a 3% increase within the most and least deprived quintiles.

Shrewsbury and Atcham became slightly less deprived when compared to other Districts in England – it experienced a 4% decrease in quintile 3 and a 2% increase in quintiles 4 and 5.

There was not much change for **South Shropshire** except a 2% increase within the least deprived quintile.

Education, skills and training deprivation overall

In Shropshire 13 out of 192 SOAs fall within the most deprived quintile nationally (15 in 2004). 4 of these fall into the 10% most deprived. These areas are located within the electoral wards of **Harlescott, Meole Brace, Sundorne** and **Battlefield and Heathgates** all in Shrewsbury and were also the most deprived SOAs for this domain in 2004.

Three areas in Shrewsbury located within **Porthill** and **Underdale** were found to be some of the least deprived in England, this highlights the sharp contrast between parts of Shrewsbury.

The number of SOAs which fall into the least deprived quintile has increased from 39 to 40 since 2004 (Table 21). An area in **Porthill** in Shrewsbury

remains the least deprived in the County with a national percentile ranking of 99%.

An SOA located in **Underdale** in Shrewsbury has seen the greatest decline in terms of deprivation since 2004. Its national percentile ranking decreased from 51% to 37% since then (quintile 3 to 2).

In contrast, an SOA located in **Ludlow Sheet with Ludford** in South Shropshire has seen the greatest improvement in terms of deprivation since 2004. Its national percentile ranking went from 63% in 2004 to 76% in 2007 (both quintile 4).



Education, skills and training deprivation affecting children and young people

In Shropshire 8 out of 192 SOAs within the County fell within the most deprived quintile nationally (6 in 2004). Three of these fell into the 10% most deprived. These areas are located within the electoral wards of **Harlescott**, and **Battlefield** and **Heathgates** in Shrewsbury, and **Stokesay** in South Shropshire.

The number of SOAs which fall into the least deprived quintile has increased from 51 in 2004 to 56 in 2007 (Table 22). An SOA in the electoral ward of **Porthill** in Shrewsbury is the least deprived in the County with a national percentile ranking of 100%.


However an SOA located in **Underdale** in Shrewsbury has seen the greatest decline. Its national percentile ranking went from 65% in 2004 to 37% in 2007 (quintile 4 to 2).

An SOA located in **Ludlow Sheet with Ludford** in South Shropshire has seen the greatest improvement in terms of deprivation levels since 2004. Its national percentile ranking increased from 54% to 79% since then (quintile 3 to 4).


In Shropshire 26 out of 192 SOAs fall within the most deprived quintile nationally. Two SOAs fall within the 5% most deprived. These areas are located within the electoral wards of **Meole Brace** and **Harlescott** in Shrewsbury.

16 SOAs fall into the least deprived quintile (Table 23). An SOA in the electoral ward of **Porthill** in Shrewsbury is the least deprived in the County with a national percentile ranking of 96%.

Barriers to housing and services

SUMMARY

- This domain and particularly the wider barriers sub-domain experienced profound change since 2004 with Shropshire County becoming more deprived.
- Overall, 40% of Shropshire's population live within the fifth most deprived areas in England and only 8% live within the least deprived fifth.
 - In particular, 58% of North Shropshire's population falls within the most deprived quintile.
 - An SOA in Lawley is the most deprived in Shropshire.
- In terms of wider barriers, 2% of Shropshire's population live within the most deprived fifth of areas in England.

 Whereas in 2004, the majority of Shropshire's population lived within
 - the least deprived fifth of areas nationally, only 4% do so in 2007.
 - The number of SOAs which fall into the least deprived quintile has decreased by 112 since 2004 to only 8 in 2007. Every single SOA in Shropshire has experienced a decline in their national percentile rankings since 2004 for this sub-domain.
- Shropshire being a rural County, experiences high levels of geographical barriers deprivation, with 47% of its population living within the most deprived fifth nationally and only 6% living within the least deprived.
 - In particular, 60% of North Shropshire's population falls within the most deprived quintile.

The Barriers to housing and services domain includes two sub-domains:

- Wider barriers
 – this includes issues relating to access to housing, such as overcrowding and affordability, as well as homelessness. The scores are derived from the following indicators:
 - ➤ Household overcrowding (2001)
 - ➤ District level rate of acceptances for applications for assistance under the homelessness provisions of the 1996 Housing Act, assigned to SOAs (2005)
 - ➤ Difficulty of Access to owner-occupation (2005)
- Geographical barriers this measures poor geographical access to key services that are important for day-to-day life. Indicators used to calculate scores are:
 - > Road distance to a GP surgery (2005)
 - > Road distance to a general store or supermarket (2005)
 - > Road distance to a primary school (2004-2005)
 - > Road distance to a post office or sub post office (2005)

Traditionally, measures of deprivation have tended to be biased towards urban areas in the sense that these areas are more likely to be depicted as deprived than rural areas. This is however not the case with the Geographical barriers sub-domain – access to services is a more pertinent issue to rural areas such as Shropshire County and is therefore particularly relevant in this case.

Barriers to housing and services overall


40% of the County's population live within the fifth most deprived areas in England – this is the most populated quintile. In contrast, only 8% live within the least deprived fifth (Table 24).

Since 2004, Shropshire County has become significantly more deprived in terms of barriers to housing and services. There has been a 17% shift of the County's population away from the least deprived fifth of areas in England, into quintile 3 (by 2%), quintile 2 (by 10%) and into the most deprived quintile (by 6%).


Quintile 3 is the most populated (with 43% of Shropshire's total population) (Table 25).

This sub-domain experienced the largest change since 2004 out of all IMD 2007 domains and sub-domains. Shropshire has become significantly more deprived since 2004. There has been a 57% drop in the proportion of Shropshire's population living within the least deprived quintile. In contrast, there has been a 31% increase in quintile 3, and a 26% increase in quintile 2, the second most deprived quintile.


47% of the County's population live within areas that fall within the most deprived quintile – this is the most populated quintile. In contrast, only 6% live within the least deprived fifth of areas (Table 26).

Shropshire has become slightly less deprived in this sub-domain since 2004. There was a 2% drop within the most deprived quintile and a 4% drop in quintile 3, and a 4% increase in quintile 4 as well as a 1% increase in quintile 2.

Barriers to housing and services overall

Out of the five Shropshire Districts, North Shropshire has the highest proportion of its population living within the most deprived fifth of areas in England (58%). Shrewsbury and Atcham had the lowest (28%).

Shrewsbury and Atcham has the highest proportion of its population living within the least deprived fifth of areas in England (11%) (Table 27).

North Shropshire became more deprived since 2004. The County experienced a 33% shift away from the least deprived quintile into the most deprived quintile (by 15%), quintile 3 (by 13%) and quintile 4 (by 5%).

Oswestry also became more deprived with a 32% decrease in the proportion of its population living within the least deprived quintile and a 20% increase living within the most deprived quintile.

Shrewsbury and Atcham experienced a 17% increase in its population living within quintile 2 areas, and a decrease in all other quintiles (including a 7% drop in the least deprived quintile).

South Shropshire also became more deprived, with a 17% drop in the least deprived quintile and a 16% increase for quintile 2.

Bridgnorth became more deprived, with an 11% decrease within the least deprived quintile and an increase for the 3 most deprived quintiles.

Wider barriers deprivation

None of Shropshire County's population lived within the most deprived quintile in 2004. In 2007, 5% of Shrewsbury and Atcham's population and 3% of North Shropshire's population live in these areas.

In contrast, whereas in 2004 all Shropshire Districts except Shrewsbury and Atcham had over half of their population living within the least deprived fifth of areas in England, this is not the case for any Shropshire District in 2007. Only Bridgnorth has inhabitants living within these areas at all (23%) (Table 28). This is an incredible shift to occur within 3 years, especially since the IMD 2004 and 2007 are comparable when it comes to this sub-domain.

Whereas in 2004, 95% of **North Shropshire**'s population lived within the least deprived quintile, none do so in 2007. 46% now live within quintile 2 and 45% within quintile 3.

A similar change occurred in **Oswestry** and **South Shropshire**.

Shrewsbury and Atcham experienced an 18% drop in the least deprived quintile as well as within quintile 2, and a 37% increase in quintile 2.

Bridgnorth seems to be the least deprived of all five Shropshire Districts. It experienced a 60% drop within the least deprived quintile, a 29% increase for quintile 4 and a 31% increase in quintile 3. However, none of its population live within areas in the most deprived or second most deprived quintiles.

Geographical barriers deprivation

Out of all Shropshire Districts, North Shropshire has the highest proportion of its population living within the most deprived quintile (60%). Shrewsbury and Atcham has the lowest (36%).

South Shropshire has the highest percentage of its populations living in the least deprived fifth of areas in England (Table 29).

North Shropshire experienced only little change from 2004 - a 3% drop in quintile 2 and a corresponding increase in quintile 4.

Oswestry became more deprived with a shift away from quintiles 4 and 3 (3% each) into quintile 2.

Shrewsbury and Atcham on the other hand, became less deprived with a shift away from quintile 2 (by 4%) and quintile 3 (by 10%) into quintile 4.

South Shropshire also became comparatively less deprived than other Districts in England with a 15% decrease in the most deprived quintile and a corresponding increase in quintile 2. There was also a 3% drop in quintile 4 and a corresponding increase in the least deprived quintile.

Bridgnorth became relatively less deprived with a 6% move away from quintile 2 into quintiles 3 and 4.

Barriers to housing and services overall

The number of SOAs which fall into the most deprived quintile nationally has increased from 63 in 2004 to 77 in 2007. There are currently 17 SOAs with a national percentile ranking of less than 1% whereas in 2004 there were only 5. SOAs in the wards of **Lawley**, **Bitterley with Stoke St. Milborough** and **Corve Valley** remain the top 3 deprived areas as they were in 2004.

The number of SOAs which fall into the least deprived quintile has fallen from 50 in 2004 to just 15 in 2007 (Table 30). An SOA in the ward of **Ludlow Henley** in South Shropshire is the least deprived, with a national percentile ranking of 94% (99% in 2004).

An SOA in **Weston Rhyn** has experienced the greatest increase in deprivation for this domain relative to other SOAs nationally. Its national percentile ranking decreased from 85% to 28% percentile since 2004 (quintile 5 to 2).

In contrast, an area in **Alveley** in Bridgnorth has experienced the greatest decrease in deprivation for this domain. Its national percentile ranking went from 66% to 90% since 2004 (quintile 4 to 5).



Wider barriers deprivation

Every single SOA in Shropshire has experienced a decline in their national percentile rankings since 2004.

In Shropshire 4 out of 192 SOAs fall within the most deprived quintile nationally – in 2004, none of the SOAs in Shropshire fell within this quintile. These are located within the electoral wards of **Castlefields and Quarry**, **Underdale**, **Castlefields and Quarry** and **Market Drayton East**.

The number of SOAs which fall into the least deprived quintile has decreased dramatically by 112 since 2004. Only 8 SOAs now fall into this quintile (Table 31).

An SOA in the electoral ward of **Bridgnorth Castle** in Bridgnorth is the least deprived in the County with a national percentile ranking of 89%. In 2004 the least deprived SOA fell in the ward of **Whixhall** in North Shropshire and had a national percentile ranking of 99%.



In Shropshire 90 out of 192 SOAs fall within the most deprived quintile nationally (94 in 2004). 7 of these have a national percentile ranking of 0%. The most deprived SOAs in Shropshire are located in **Corve Valley**, **Lawley** and **Bitterley with Stoke St. Milborough**.

13 SOAs fall within the least deprived quintile nationally (12 in 2004) (Table 32). An SOA in the electoral ward of **Castle** in Oswestry is the least deprived in the County with a national percentile ranking of 96%.



Crime and disorder deprivation

SUMMARY

- 3% of Shropshire's population live within the most deprived fifth of areas in England and 48% live within the least deprived fifth.
- Levels of crime in the county are relatively low in Shropshire. The most deprived areas fall mostly within the urban areas of the County.
- The most deprived SOA is located within the electoral ward of Castle in Oswestry.

The purpose of this domain is to measure the rate of recorded crime for four major volume crime types – burglary, theft, criminal damage and violence – representing the risk of personal and material victimisation at a small area level.

The indicators used to measure this aspect of deprivation are:

- Burglary (4 recorded crime offence types, April 2004-March 2005)
- Theft (5 recorded crime offence types, April 2004-March 2005)
- Criminal damages (10 recorded crime offence types, April 2004-March 2005)
- Violence (14 recorded crime offence types, April 2004-March 2005)

3% of Shropshire's population live within the most deprived fifth of areas in England. In contrast, 48% live within the least deprived fifth – this is the most populated quintile (Table 33).



SHROPSHIRE DISTRICTS

Out of all five Shropshire Districts, Shrewsbury and Atcham has the highest proportion of its population living within the most deprived fifth of areas in England (7%). North Shropshire, South Shropshire and Bridgnorth have none.

South Shropshire has the highest proportion of inhabitants living within the least deprived fifth of areas (82%) (Table 34).

North Shropshire became less deprived since 2004, with a shift away from the most deprived quintile (by 3%) and 2nd quintile (by 9%) into the least deprived quintile (by 8%) and quintile 3 (by 3%).

On the other hand, **Oswestry** became more deprived since 2004, with a shift away from the least deprived quintile (by 6%) and the 4th quintile (by 3%) into the 2nd quintile (by 6%) and 3rd quintile (by 2%).

Shrewsbury and Atcham experienced a modest shift away from the extremes – quintiles 1, 4 and 5 – into quintiles 2 and 3.

South Shropshire became less deprived overall since 2004. None of its population lives within the 2 most deprived quintiles in 2007 and the proportion living within the least deprived quintile has increased by 26%.

Bridgnorth has become comparatively more deprived since 2004 then other Districts in England. The District has experienced a shift away from the least deprived quintile (by 7%) and quintile 4 (by 8%) into quintile 3 (by 6%) and quintile 2 (by 8%).

SHROPSHIRE SOAs

Levels of crime in the county are relatively low in Shropshire. The most deprived areas fall mostly within the urban areas of the County, as is often the case.

In total 5 SOAs fall within the most deprived quintile (8 in 2004). The most deprived of these fall within the electoral wards of **Castle** (Oswestry) and **Castlefields and Quarry** (Shrewsbury) and have a national percentile ranking of under 15%.

The number of SOAs which fall into the least deprived quintile nationally has risen from 87 in 2004 to 94 in 2007 (Table 35). The least deprived SOA is located in the ward of **Donington and Albrighton** in the district of Bridgnorth with a national percentile ranking of 100.

The greatest decline has been seen in the ward of **Cambrian** in Oswestry District which has seen its national percentile ranking fall from 80% in 2004 to just 31% in 2007 (quintiles 4 to 2).

The greatest improvement has been seen in the ward of **Bagley** in Shrewsbury which has seen its national percentile ranking increase from 49% in 2004 to 91% in 2007 (quintile 3 to 5).



- Overall, 8% of Shropshire's population live within the most deprived fifth of areas in England and 24% within the least.
- In terms of 'indoors environment' deprivation, 22% of Shropshire's population live within the most deprived quintile and 13% live within the least. In particular, 42% of South Shropshire's population fall within the most deprived quintile.
- In terms of 'outdoors environment' deprivation, only 1% of Shropshire's population live within the most deprived fifth of areas in England and 68% live within the least.
- The most deprived area is located within the electoral ward of Bitterley with Stoke St Milborough in terms of living environment overall and the indoors sub-domain. An SOA in Underdale is the most deprived in terms of the outdoors sub-domain.

This domain measures deprivation relating to characteristics of the living environment.

It includes two sub-domains:

- The 'indoors' living environment this measures quality of housing. The scores are derived from the following indicators:
 - Social and private housing in poor condition (2003-2005)
 - ➤ Houses without central heating (2001)
- The 'outdoors' living environment this contains measures about air quality and road traffic accidents. Indicators used to calculate scores:
 - > Air quality (2005)
 - > Road traffic accidents involving injury to pedestrians and cyclists (2004-2006)

Living environment deprivation overall

8% of Shropshire County's population lives within the most deprived fifth of areas in England. This compares to 24% who live within the least deprived quintile.

The two most populated quintiles are quintile 2 (25%) and the least deprived quintile (24%) (Table 36).







Living environment deprivation overall

Out of all five Shropshire Districts, South Shropshire has the highest proportion of its population living within the most deprived fifth of areas in England (20%). In contrast, Shrewsbury and Atcham has the lowest, with none of its population living within these areas.

In terms of the proportion of the Districts' population living within the least deprived quintile, Shrewsbury and Atcham has the highest (40%) (Table 39).

Since 2004, **North Shropshire** experienced an 8% drop from quintile 3, into the most deprived quintile (by 5%) and the least.

Oswestry became more deprived since 2004, with a drop within the least deprived quintile (by 3%) and quintile 4 (by 6%) into the other 3 quintiles.

Since 2004, the picture for **Shrewsbury and Atcham** was less straightforward. There was a 12% increase in the least deprived quintile, and a 5% in quintile 2. There was a 13% decrease within quintile 3.

South Shropshire became more deprived, with a move away from the 2 least deprived quintiles into quintile 3 and a move away from quintile 2 (by 13%) into quintile 1 (by 11%).

Out of all five Shropshire Districts, South Shropshire has the highest proportion of its population living within the most deprived quintile (42%) and Shrewsbury and Atcham the lowest (8%).

Shrewsbury and Atcham has the highest proportion of its population living within the least deprived quintile (28%) (Table 40).

Since 2004, **North Shropshire** has not experienced much change.

Oswestry experienced a 15% drop from quintile 3, spread evenly between quintiles 2 and 4.

Out of all five Shropshire Districts, only Shrewsbury and Atcham has some of its population living within the most deprived quintile (2%).

In contrast, South Shropshire has the highest proportion living within the least deprived quintile (94%) (Table 41).

There has not been much change for **North Shropshire** since 2004 – its population is split between the least deprived quintile and quintile 4 only.

Oswestry experienced a 9% drop in the least deprived quintile and a corresponding increase in quintile 4. There was also a small move from quintile 2 to 3.

17 out of 192 SOAs in Shropshire fall into the most deprived quintile nationally (9 in 2004). The most deprived area is located within the electoral ward of **Bitterley with Stoke St Milborough** in South Shropshire with a national

percentile ranking of 8%. Other SOAs falling within the most deprived 15% are located in Corve Valley, Castle, Kemp Valley, Ellesmere and Welshampton, Whitchurch North, Shavington and Broseley West.

The number of SOAs which fall within the least deprived quintile has increased from 36 SOAs in 2004 to 46 in 2007 (Table 42). The least deprived SOA is located in **Bowbrook**.

An SOA within the ward of **Bowbrook** in Shrewsbury has experienced the greatest level of decline. Its national percentile ranking decreased from 71% in 2004 to just 35% in 2007 (quintiles 4 to 2).



In Shropshire 42 out of 192 SOAs fall within the most deprived quintile nationally (43 in 2004). 3 of these have a national percentile ranking of under 5%. These are **Bitterley with Stoke St. Milborough, Corve Valley** and **Kemp Valley**, all in South Shropshire.

The number of SOAs which fall into the least deprived quintile has increased from 23 in 2004 to 26 in 2007 (Table 43). An SOA in the electoral ward of **Bowbrook** in Shrewsbury is the least deprived in the County with a national percentile ranking of 99%.



'Outdoors' living environment deprivation

In Shropshire, only 1 out of 192 SOAs falls within the most deprived quintile nationally, this SOA is located in the electoral ward of **Underdale** in Shrewsbury. No Shropshire SOA fell within this quintile in 2004.

The number of SOAs which fall into the least deprived quintile has decreased from 132 in 2004 to 130 in 2007 (Table 44). An SOA in the electoral ward of **Worthen** remains the least deprived in the County with a national percentile ranking of 100%, unchanged from 2004.



District and County Summary

SUMMARY

- Overall, Shropshire is a relatively affluent area
- Using the average population-weighted scores, Shropshire is ranked as being the 106th most deprived County out of 149 Counties in England (111th in 2004)
- There are six summary measures that can be used at District level, these are: Average Score, Average Rank, Extent, Local Concentration, Income Scale and Employment Scale. Out of all Shropshire Districts, Shrewsbury and Atcham appeared the most deprived in terms of all of these except average score (Oswestry) and average rank (North Shropshire). Bridgnorth appeared least deprived in terms of all measures except income scale and employment scale (both South Shropshire)

The Index of multiple deprivation at SOA level is summarised at County and District level using 6 different measures, allowing us to compare Shropshire deprivation levels with other Counties and Districts in England (Table 45).

These measures focus on different aspects of multiple deprivation and no single summary measure is favoured over any other.

Table 45 Definition of summary measures used for Counties and Districts

The 'Average Scores' and 'Average Ranks' measures are two ways of depicting the average level of deprivation across the entire County or District. These are the population-weighted averages of the combined scores and ranks for the SOAs in a County or District.

The **'Extent'** measure is the proportion of a County's or District's population living in the most deprived SOAs in England.

The 'Local Concentration' measure shows the severity of multiple deprivation in each County and District by measuring 'hot spots' of deprivation. It is the population-weighted average of the ranks of the County or District's most deprived LSOAs that contain exactly 10% of the County or District's population.

'Income Scale' is the number of people who are income deprived.

'Employment Scale' is the number of people who are employment deprived.

SHROPSHIRE COUNTY

Average Score

Overall, Shropshire is a relatively affluent area.

When looking at average scores, Shropshire ranks as the 106th most deprived County out of a total of 149 in England. In 2004, Shropshire ranked 111th – and has therefore become more deprived since then.

Average Rank

In terms of average rank, Shropshire ranks 101st out of 149. In 2004, it ranked 105th – showing that Shropshire has become slightly more deprived when compared to the other Counties in England.

Extent

In 2007, 3% of Shropshire County's population lived in the most deprived SOAs in England. In 2004 this was 2% but compared to other Counties, it has retained its rank of 135th out of 149.

Local Concentration

Shropshire ranks 133rd out of 149 for this measure – this represents a marginal improvement on 2004's rank of 132nd.

Income Scale

Shropshire ranks 109th out of 149. This is unchanged form 2004.

Employment Scale

Shropshire's rank in 2007 is 101st out of 149 (Table 46). This is improved from 2004's rank of 96.

SHROPSHIRE DISTRICTS

Average Score

When looking at Shropshire Districts, Oswestry is the most deprived relative to the others, ranking 173rd most deprived out of 354 Districts in England. It is closely followed by North Shropshire, ranking 175th.

The least deprived District in Shropshire according to this measure is Bridgnorth, ranking at 243.

Since 2004, South Shropshire has overtaken Shrewsbury and Atcham as being more deprived. Relative ranks of Shropshire Districts are otherwise unchanged.

Since 2004, all Shropshire Districts have become more deprived relative to all other Districts in England, except Oswestry that retained its rank. South Shropshire increased in deprivation the most, having become more deprived by 11 rank places.

Average Rank

According to this measure, North Shropshire is the most deprived with a rank of 154 out of 354 and Bridgnorth is the least with a rank of 236.

Since 2004, North Shropshire overtook Oswestry as the most deprived District in Shropshire – relative ranks are otherwise unchanged.

Since 2004, all Shropshire Districts became comparatively more deprived, apart from Oswestry that became less deprived by 2 rank places. Levels of deprivation increased the most for South Shropshire, having become more deprived by 19 rank places.

Extent

Out of all the Districts in Shropshire, Shrewsbury and Atcham has got the highest percentage of its population living in the most deprived SOAs in England (5%). It ranks as the 192nd most deprived District out of 354. In contrast, Bridgnorth has 0% and ranks 309th.

Since 2004, North Shropshire became more deprived than South Shropshire – the other relative ranks were unchanged.

Since 2004, only Shrewsbury and Atcham became comparatively more deprived for this measure – by 12 rank places. North Shropshire retained its rank. 3 Districts became less deprived: South Shropshire (by 19 rank places), Bridgnorth (by 11 rank places) and Oswestry (by 2 rank places).

Local Concentration

Shrewsbury and Atcham was the most deprived out of all Shropshire Districts for this measure – it ranked 183rd out of 354. Bridgnorth was the least deprived with a rank of 283.

The relative rank of the Shropshire Districts did not change from 2004.

Since 2004, Shrewsbury and Atcham became comparatively more deprived (by 14 rank places) as well as South Shropshire (by 9 rank places). The other 3 Counties became less deprived, each by a small number of rank places.

Income Scale

Shrewsbury and Atcham is the most deprived of all other Districts in Shropshire for this measure – it ranks 225^{th} out of 354. South Shropshire is the least, with a rank of 340^{th} .

Since 2004, Bridgnorth became more deprived than Oswestry. The relative rank of Shropshire Districts did not otherwise change.

Since 2004, every District in Shropshire became comparatively less deprived. The largest improvement occurred in Oswestry (by 11 rank spots).

Employment Scale

Shrewsbury and Atcham is the most deprived District in Shropshire for this measure, with a rank of 215th out of 354. South Shropshire is the least, with a rank of 343 (Table 47).

The relative ranks of Shropshire Districts stayed the same from 2004.

Since 2004, all Shropshire Districts became less deprived when compared to all Districts in England. North Shropshire and Shrewsbury and Atcham improved the most (by 15 rank spots each).
