To qualify for any travel assistance an application must be submitted for each individual applicant.

Where it is considered that travel assistance is necessary it will be arranged in the most cost-effective way and will focus on support that will aim for or enable the learner to travel as independently as possible.

For **Nursery & Post 16** ages the agreed level of contribution for the 2022/23 academic year is £918. For families on defined benefits a contribution towards the cost of the transport assistance will be £294 for the academic year. Full details can be found on the last page of this document.

INDEPENDENT TRAVEL TRAINING

Independent Travel Training (ITT) is one-to-one training designed to equip young people who are entitled to home to school/college travel assistance with the confidence and skills required to travel independently, be it on foot, cycling or public transport. A trainer works with the learner to create a personalised programme to develop their independence and confidence. All passengers are regularly assessed for their ability to undertake this important life skill, more information can be found by emailing special.transport.team@shropshire.gov.uk

PERSONAL TRAVEL BUDGETS & PARENTS TRAVELLING EXPENSES

Personal Travel Budgets (PTB) are provided only for Statutory aged students (5 to 16 years old) attending an educational facility full-time. A PTB is a sum of money allocated to parents/carers to enable them to make their own home-to-school travel arrangements, one that suits their families needs. Payment is calculated on an individual basis, taking into consideration the child's needs as well as the current cost to the local authority for transporting your child to school. Once agreed, 11 monthly instalments over an academic year will be paid into a nominated bank account at the beginning of the month. Parents Travelling Expenses (PTE) are offered to parents of Nursery and Post 16 applicants only on a pre-agreed daily mileage.

COUNCIL PROVIDED MINIBUSES & TAXIS

For students accessing this service we can offer a taxi or bus on a shared basis and as such the service will collect in the morning to arrive at school opening times and then return at the end of the school day. Specific timetables will not be catered to and if a student wishes to arrive later or leave early then it will be the parent's responsibility to provide this. It takes a minimum of 5 working days to organise this arrangement and make any changes to it. This service is reviewed regularly to make sure the council is getting best value for money and as such the operator/driver can change frequently.

PASSENGER ASSISTANTS

Please be aware that Passenger Assistants are not immediately provided for each applicant. The decision on whether one is required for a passenger will be made by the Specialist Travel Team based on the information provided. They are usually provided due to a medical need such as the administration of Rescue Medication (Buccal Midazolam) in the event of a prolonged seizure or due to the amount of passengers on board at one time.

CONTRIBUTION PAYMENT FOR NURSERY & POST 16 APPLICANTS

There isn't a statutory duty to provide transport for Nursery (Under 5's) or Post 16 aged students (16 to 18 year olds), although we currently offer a contribution scheme for Nursery & Post 16 students with an education, health and care (EHC) plan attending their designated/nearest assessment nursery or Post 16 establishment.

The agreed level of contribution for the 2022/23 academic year is £918. Payment can be split into three termly payments, payable prior to the start of each term, no refunds are issued for reduced or cancelled travel.

For families on defined benefits (please see below), a contribution towards the cost of the transport assistance will be £294 for the academic year. This can also be split into three termly payments and no refunds are issued for reduced or cancelled travel.

- Income Based Job Seekers Allowance
- Income Support
- Free School Meals – as authorised by the Authority, not the college that your son/daughter is attending
- Child Tax Credit with annual income, as assessed by HM Revenue & Customs, of less than £16,190 on 1st September 2021 or subsequently on the date of application.
- Income related Employment and Support Allowance
- Universal credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods)

Entitlement will need to be reassessed on an annual basis and necessary evidence must be supplied.

We assess every young person on their individual needs. The obligations that apply to school transport derive from the Education and Inspections Act 2006, (in particular section 508 A-G), and the Department for Education post-16 transport to education and training guidance.
