A total distance of approximately 121 metres **onto a line** leaving the Bletchley to Moreton Say Road at a gate at point C on the Order map at grid reference SJ 6290 3426 running in a general WNW direction with a defined width of 2 metres to re-join the Definitive line of FP 3 at a gate at point B on the Order map at grid reference SJ 6287 3427. A total distance of approximately 34 metres.
