## THE SHROPSHIRE COUNCIL (FOOTPATH 1B (PART), PARISH OF LONGDEN) PUBLIC PATH DIVERSION ORDER 2023

The above named order made on 7<sup>th</sup> September 2023, by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981, will;

**divert** the full width of the part of Footpath 1B from point A on the Order Map grid reference SJ 4526 0783 where it leaves the County Road, running in a general south easterly direction across the access and garden of No 2 The Hazels for approximately 40m to a stile where it meets the continuation of Footpath 1B at Point C on the Order Map grid reference SJ 4528 0779 **onto a line** from Point B on the Order Map grid reference SJ 4528 0784, where it leaves the County Road, a footpath will be created running in a general SSE direction along a surfaced access track with a width of 2.5 metres then turning to run in a general SSW direction along a grass track between boundaries with a width of 3 metres to a stile at Point C on the Order Map grid reference SJ 4528 0779 where it meets the continuation of footpath 1B. The route has a total distance of approximately 48m.
