Footpath 21 (part)

The whole width of footpath 21 (part) from grid reference: SJ 4737 1936 running in a general north-north-west, then westerly, then north-north-west, then northerly direction to the junction of public footpaths 20 and 21 at grid reference: SJ 4727 1957. An approximate distance of 253 metres.
