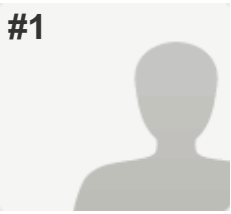

Object

As the Headteacher of Idsall School I have repeatedly stated that the development of Shifnal will result in there being no places to offer families moving into the area with children. We are currently a full school with no additional classroom space. Indeed there are 5 occasions in the school week when we have no available classrooms. This issue has been raised locally and with Shire Hall but the response seems to be that as we take students from surrounding areas of Telford we will have spaces for Shifnal children by denying Telford children places. Whilst this can apply in Yr 6 for students applying for places in Yr7 - and does as part of Shropshire's admission policy - it cannot apply for students who are currently in the school. This means we have an issue of places for at least 4/5 years and I can foresee the situation of a family moving into new housing in the next 4 years and unfortunately being refused a place. When this issue was raised with Shropshire LA the response following a survey was to state that we have capacity in the school. Incredibly two areas suggested to me were to teach 60 students in the canteen and 8 students in my office!! We desperately need support to purchase temporary accommodation to support us through this transitional period but I cannot see this on the neighbourhood plan. <p>2. Local context Comment:</p>	<p>Support I take issue with the statement on p6 that Shifnal does not have a noticeably high proportion of commuters that travel by train. There are an increasing number of commuters travelling by car to Shifnal from surrounding places such as Bridgnorth (which has no railway station) and even parts of Telford (where car parking is charged at the station). One attraction is the free all-day parking in Shifnal. This is increasing the congestion within the town and means that car parking for shoppers and local business users is restricted.</p>

### 4. Green belt and the Shifnal settlement

Comment:

Support

Most of the safeguarded land within Shifnal's Settlement Boundary is currently undergoing housing development with a resulting large increase in the population of the town. It is vital that there is now a period of adjustment and consolidation. The current infrastructure is going to be sorely stretched with insufficient funding to address the increasing needs. Further growth of the town is undesirable. It is therefore essential that the present Green Belt Boundary is maintained. The rural surroundings of the town are valued by Shifnal residents and the Green Belt Boundary is a protective buffer against the town sprawling over an even bigger area and joining with Telford.

### 5. Housing

I strongly support the Neighbourhood Plan's view that it is not appropriate to allocate further sites for housing development apart from infill development within the Settlement Boundary.

### 6. Transport and movement

Comment:

Support

I have concerns about the increase in traffic moving through the town which is not just the result of the increase in Shifnal's population (though obviously this is a factor) but also the result of a big increase in housing in surrounding areas, mainly parts of Telford. I fully support the Neighbourhood Plan's policies for addressing this issue and I am also in favour of the town centre improvements proposed by SCC. Speed restriction is a vital component of these plans.

I feel that this is a very important facility for a town the size that Shifnal to have. All children should have the opportunity to learn to swim, and swimming is a safe and healthy exercise for people of all ages. There has been an enthusiastic community group of people planning for and raising money for a swimming pool for many years.

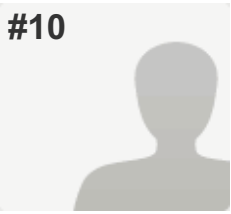
